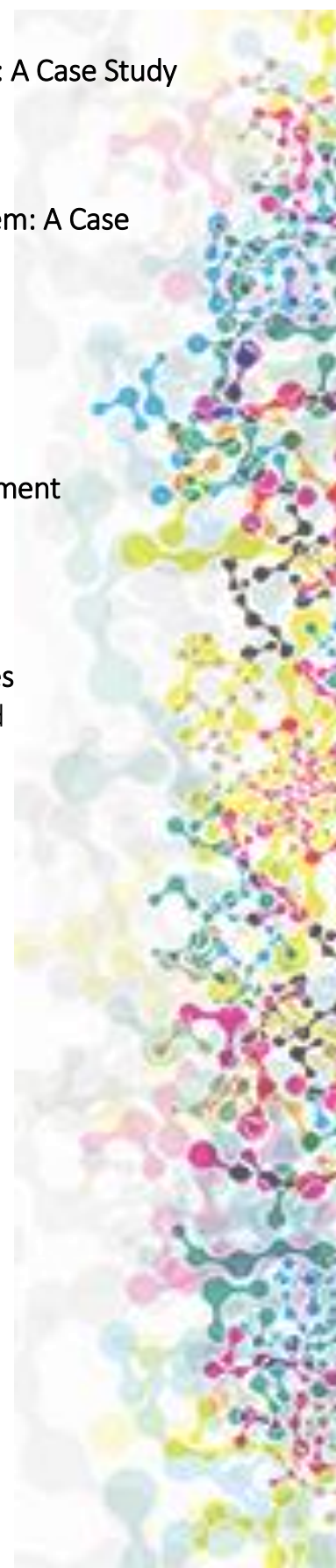

Conference Fees

As usual, HSRAA offers a range of pricing options including:

- **Full Delegate:** Two nights' bed-and-breakfast accommodation, checking-in on Wednesday 8th May (check-out Friday 10th May), 2-day conference, networking reception and conference dinner on Thursday 9th May, and all conference session refreshments.
- **Day Delegate:** Admission to the conference sessions on 9th May or 10th May, including lunch and refreshment breaks. This rate does **NOT** include accommodation or the networking reception and conference dinner.
- **Accommodation:** One-night bed-and-breakfast accommodation at the HSRAA special rate, available for 8th / 9th May and 9th / 10th May. Book via the HSRAA website to secure our special rate (not available directly with the hotel).
- **Networking Reception and Dinner:** For day delegates or delegates wishing to bring a guest.
- **Workshop:** One half-day pre-conference workshop on 8th May, including refreshment break.

HSRAA members whose membership is fully paid at the time of booking will be entitled to a **25% discount** on the non-member rates shown below. The member rate will be displayed and available for selection only when logged into the HSRAA website as a member.

1. HSRAA has only a limited number of rooms available at The St. David’s Hotel. Once these places have been filled, you will only be able to attend by purchasing day delegate passes and making your own accommodation arrangements, either at the conference hotel or elsewhere. If full payment has not been received and additional bookings are received for the full delegate rate, preference will be given to delegates paying in full immediately. For this reason, we strongly recommend booking early and ensuring your payment is made promptly. For our last three conferences, the full delegate passes have been sold out.

HSRAA is unable to book additional nights for delegates on your behalf or to provide accommodation arrangements that differ from that described above. **However, please include your hotel for either or both of the conference days on your booking to benefit from our special rates.** If your company has or uses a Travel Group, please include the standard days on your conference booking and then have them make any additional arrangements on your behalf once your booking with us is complete.
